Bidding Documents

The bidding Terms & Conditions are as under: -

1. The bid prices shall be valid for the current financial year.
2. (i) The bid must accompany bid security / earnest money of Rs.25,000/- in the form of Call Deposit / Bank Draft (refundable) drawn in favor of Addl Dir (A&F), NAB Khyber Pakhtunkhwa. Sealed bids along with Call Deposit / Bank Draft must reach the undersigned not later than 1030 hours on 16.11.2017 which will be opened in front of Purchase Committee on the same date at 1100 hrs in presence of bidders or their authorized representatives.

(ii) Bids without bid security / earnest money will not be entertained.
3. The bidders should also attach their profiles (containing relevant experience, past performance, capability with respect to personnel etc) with the bids. Preference will be given to the firms who are operating business in major cities of the country and are in the field for at least five years. The firms having experience in supply of required equipment to reputed Government organizations must attach copies of purchase orders with their bids.
4. Warranty period should be mentioned in the quotations (where required).
5. Prices should be quoted in Pak Rupees only.
6. The successful bidder will provide performance guarantee equivalent to 10% of his bid value in the shape of Bank Guarantee for warranty period in favor of Addl Dir (A&F), NAB (KP).
7. The Bank Draft/ Pay Order of the unsuccessful bidders will be released after deciding the successful bidder.
8. The successful bidder shall supply the ordered goods within 15 days after signing the contract agreement/issuance of purchase order.
9. Rates must be inclusive of all Govt: Applicable Taxes.
10. Income Tax as applicable or announced by the GOP will be deducted at source.
11. No advance payment will be permissible.
12. The payment will be made after successful supply of requisite items.
13. Bidders will have to produce the proof of GST registration. **They must be filer and shall require to be in active tax payer list.**
14. No deviation from specification will be accepted.
15. Any attempt by a Bidder to influence in the examination, evaluation, comparison, and post qualification of the Bids or Contract award decisions may result in disqualification of the firm.
16. The quantity of required items may be increased or decreased on the basis of available budget requirement.
17. The Competent Authority of NAB (KP) reserves the right to accept or reject all bids as per rule 33 of PPRA Rules, 2004.
